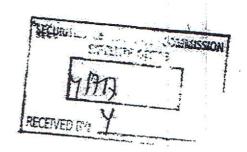

### ARTICLES OF INCORPORATION



OF

### MAA GENERAL ASSURANCE PHILIPPINES, INC.

### KNOW ALL MEN BY THESE PRESENTS:

That we, residents of the Philippines, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the Republic of the Philippines.

### AND WE HEREBY CERTIFY:

FIRST. - That the name of the Corporation shall be

### MAA GENERAL ASSURANCE PHILIPPINES, INC.

SECOND. - That the purposes for which this corporation is formed are as follows:

- (a) To engage in the business of undertaking for a consideration to indemnify other against loss, damage or liability arising from unknown or contingent events in the following matters, and particulars, to wit:
  - (1) To guarantee the fidelity of persons holding places or public or private trust and to execute and guarantee bonds and undertaking in judicial proceedings to agree to the faithful performance of any contract or undertaking made with any public authority;
  - (2) To guarantee the performance of contracts, agreements, undertakings, obligations, promises or duties of all kinds;
  - (3) To guarantee the performance of insurance contracts where surety bonds are acceptable for such purposes;
  - (4) To execute and to guarantee bonds and undertakings of all kinds, required or permitted to be taken in any and all actions, proceedings, negotiations, importation, exportations, or other transactions or operations, either by private individuals, or by heads of departments, courts, judges, officers, boards of bodies whether executive, legislative, or judicial;
  - (5) To guarantee to indemnify merchants, traders, and those engaged in business and giving credit, from loss or damage by reason of giving and extending such credit to their customers or persons dealing with them;

- (6) To indemnify against loss by burglary, theft, forgery, embezzlement or by any or more such happenings;
- (7) To guarantee to indemnify the owners and users of steam boilers and pipers, or fly wheels, engines of all kinds of machinery, against explosion or damage to life or property resulting therefrom, and against loss of use or occupancy caused thereby, and against liability unto third persons by any of said causes; and to make inspection of, and to issue certificates of inspection upon such boilers, pipes, fly wheels, engine and machinery;
- (8) To guarantee to indemnify the owners and users of horses, cattle and livestock against loss by death of same, by theft of same or by disabling accidents, or any or all of said causes;

- (c) To issue marine insurance covering steamers or sail boats, goods and merchandise, and other things of value loaded in said steamers, sailboats, airplanes, trains, trucks, and trailers and all other forms of conveyance by land, water, or by air;
- (d) To appoint such general agents, sub-agents or representative locally or in foreign countries, and to conduct a general insurance agency and insurance brokerage business;
- (e) To accept agency on commission bases for bond, fire and marine insurance companies of for insurance against any risk of any kind of accidents;

### CONFIRMATION OF PAYMENT OF FINES

The MAA GENERAL ASSURANCE PHILIPPINES, INC. registered on May 8, 1950 with approved extension of term on October 11, 1999 violated the Section 16 of the Code in relation to SEC Memorandum Circular No. 6, series of 2016, by not indicating the specific address in its Articles of Incorporation.

The corporation was directed to pay a total fine of P 5,000.00 paid on December 22, 2016 under Official Receipt No. 1504564.

This serves as a confirmation that the corporation has paid the fines for its failure to comply with the above-stated requirements. However, in case the corporation is subject of a complaint or investigation by the Commission or any party, the computation of penalty may be for years, earlier than five (5) years and imposition of fine shall also be made if warranted.

It is warned that if the corporation commits a similar violation in the future, the Commission shall be constrained to impose heavier penalties on the corporation and/or its responsible officers.

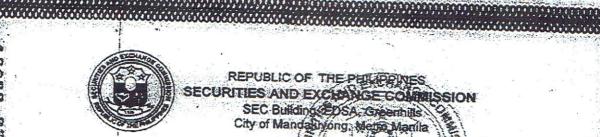

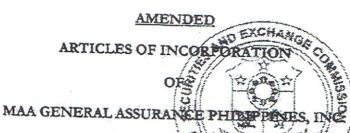

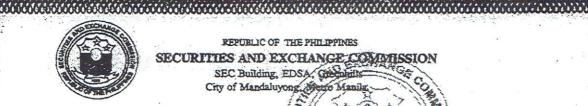
